And

The Faculty of Science and Mathematics (FSM)
Diponegoro University, Indonesia

This Agreement is made between The College of Environmental Studies, National Dong Hwa University, Taiwan hereafter referred to as CES-NDHU and The Faculty of Science and Mathematics, Diponegoro University, Indonesia, hereafter referred to as FSM-UNDIP. The agreement specifically involves the Collaborative Research, Joint Publication, Academic Staff and Student Exchanges between CES-NDHU and FSM-UNDIP.

TERMS OF COOPERATION

1. The College of Environmental Studies, National Dong Hwa University, Taiwan (**CES-NDHU**), and The Faculty of Science and Mathematics, Diponegoro University (**FSM-UNDIP**), Indonesia have agreed to develop cooperation in research and education.
2. The aims of the memorandum of understanding are to improve the competence of scientific staff and graduates, and to increase international collaboration in research and education.
3. The CES-NDHU and The FSM-UNDIP agree to promote and develop cooperation through the following activities:
 - A. **Joint Research Program for Academic Staff Members**
Joint research for academic staff members will be initiated starting from the date of signing the PoO until 2024. The topics of research activities may include research related to interdisciplinary approaches, including Marine Ecology and Aquaculture, Ecology and Biodiversity, Biology, Molecular Biology, Biotechnology, Physics, Chemistry, Computing Science, Environmental Science, Information Science, Mathematics, Applied Informatics and Technology, Mathematical Models and Molecular Life Science. In accordance with the intellectual and other property right issues, a material transfer agreement (MTA) or research collaboration agreement will be applicable and the general rules for the Project or any movement of materials will be explained in a separate legally binding agreement.
 - B. **Joint Publication, Seminar and Workshop**
Every scientific result of joint research that may be presented in an international seminar, workshop or published in an international journal has to be approved by the Scientific Supervisor from both faculties.
 - C. **Academic Staff and Student Exchanges**
In the frame work of cooperation, academic staff and students shall be involved in the exchange program, by visiting the location of both partners to contribute to formal education. The academic staff may also be included in a visiting lecture program. For the students, the regulation of credit transfer agreement (CTA) will be applicable and the general rules of the CTA will be explained separately.


GOVERNING PRINCIPLE

1. In order to assess the effectiveness of the activities under the Agreement, the cooperation will be monitored and evaluated each year during the time period of the Agreement and reported to the Dean of CES-NDHU and the Dean of FSM, Diponegoro University.
2. The Agreement does not limit the right of either institution to enter into any similar agreement of cooperation with other institutions.
3. This Agreement will remain in force for the period of 5 (five) years, unless either Party exercises their right to terminate it by giving written notice of their intention to do so. Such notice has to be given at least 12 (twelve) months in advance.

DECLARATION


